ORDER :

In the G.O. first read above, orders were issued for constituting the Tamil Nadu Scavenger's Welfare Board headed by the Minister for Adi Dravidar Welfare for the socio-economic and educational development of Scheduled Castes. In the G.Os second and third read above, each Rs.1.00 crore has been sanctioned to the above Welfare Board to grant various financial assistance to the enrolled members of the Board and their dependants during the year 2008-2009 and 2009-2010.

2. The Managing Director, TAHDCO, (Member Secretary of the Board) has now requested the Government to accord sanction for a sum of Rs.1.00 Crore as provided in BE 2010-11 for implementation of welfare measures to be implemented through the Tamil Nadu Scavenger's Welfare Board.

3. The Government, after careful examination of the request of the Managing Director, TAHDCO, accord sanction for a sum of Rs.1,00,00,000/- (Rupees One Crore only) for granting financial assistance under various welfare schemes of the Tamil Nadu Scavenger's Welfare Board. (The list of schemes and quantum of assistance is enclosed in the Annexure to this order)

4. The amount sanctioned in para 3 above shall be debited to the following head of account:

“2235 Social Security and Welfare -60 – Other Social Security and Welfare Programme 200 Other programmes – Schemes in Eleventh Five Year Plan –II State Plan – KS-sanitary workers welfare Board-09 Grants-in aid -03-Grants for Specific Schemes (DPC 2235 – 60 – 200 KS 0930)”

The Commissioner of Adi Dravidar Welfare is empowered to superwise the overall expenditure made under this Head of Account.

5. The Commissioner of Adi Dravidar Welfare is authorized to draw and deposit the amount sanctioned in para 3 above by means of Cheque in favour of Personal Deposit Account of the Member - Secretary, Tamil Nadu Scavenger's Welfare Board and the sanctioned amount shall be credited into the following head of account.
